In this case, the article is a set of quotes from various sources. The article completes the list of sources used. However, critical understanding, the author's approach is absent. There is an excess quotation.

This is connected with such a complex phenomenon as a teacher's blogomania.

Unfortunately, many teacher online pages suffer from an excess quotation from other blogs, sites. Copyright is observed. But the utility in such resources is little.

Only the teacher who possesses a sufficient culture of citation, coming by copyright, has a moral right to demand from students independence in the performance of creative work.

The teacher must formulate its requirements for student projects, abstracts, reports, orienting the wards for creative attitude, research, analysis.

Very much depends on the given topic. If the teacher selects the original few studied or not studied topics, is already a guarantee of exclusivity, authorship.

Checking writings, essays, reports, abstracts will help alleviate antiplagiat.

The use of this system should be prevented by students in advance. This will help to strengthen the responsibility of the guys.

This project is known to university educators since 2005. The system base has more than 60,000,000 sources.

Using antiplagiat, the teacher should be considered with some chance of verification.

Secondly, to achieve greater objectivity, would advise several antiplagiates that can show completely different results.
